



The need


- 1. Administer all incoming privacy requests in a single place.

The challenge

Previously, we used OneTrust. It was very complex to administer and maintain. Completing a single DSAR request took many steps and was very time-consuming. It wasn't always clear what the customer experience was like during the workflow. Automations were possible but very difficult to set up. The day-to-day process was very similar to Mine, but Mine just does it better, faster, and with a more intuitive UI.
